SUMMER STOCK RUNS FROM SUNDAY, JULY 10 THROUGH SATURDAY, AUGUST 13, 2011. SUMMER STOCK HOURS ARE 9:00 AM TO 5:00 PM MONDAY THROUGH FRIDAY FOR THE FIRST THREE WEEKS, JULY 11 THROUGH JULY 29, AND FROM 9:00 AM TO 10:00 PM MONDAY THROUGH SATURDAY FOR THE FINAL TWO WEEKS, AUGUST 1 THROUGH AUGUST 13. PARTICIPANTS MUST COMMIT TO THE ENTIRE SCHEDULE UNLESS PERMISSION HAS BEEN GRANTED IN ADVANCE BY THE EXECUTIVE DIRECTOR. LESS THAN FULL PARTICIPATION MAY LIMIT THE PARTICIPANT'S OPPORTUNITIES FOR LEADING OR FEATURED ROLES. IF GRANTED, THERE WILL BE NO TUITION DISCOUNT FOR LIMITED PARTICIPATION.

EVERY PARTICIPANT WILL BE CAST IN AT LEAST TWO OF THE FOUR PRODUCTIONS. NO PARTICIPANT IS GUARANTEED A LEADING OR FEATURED ROLE OR SOLO PERFORMANCE IN SUMMER STOCK. ROLES WILL BE CAST BASED ON AUDITIONS AS PART OF THE SUMMER STOCK EXPERIENCE.

TUITION MAY BE PAID IN TOTAL WITH REGISTRATION OR WITH THE FOLLOWING SCHEDULE:

- \$480. DUE ON OR BEFORE MONDAY, MAY 16, 2011. (*NON-REFUNDABLE AFTER JUNE 1, 2010*)
- \$480. DUE ON OR BEFORE FRIDAY, JUNE 10, 2011 (*NON-REFUNDABLE AFTER FRIDAY, JULY 1, 2011*)

A SPOT WILL BE CONFIRMED FOR A PARTICIPANT UPON RECEIPT OF COMPLETED REGISTRATION FORM AND DEPOSIT OF \$425. THE SPOT MAY BE RESCINDED IF PARTICIPANT FAILS TO MEET OTHER PAYMENT DEADLINES AND MAY BE GIVEN TO A PARTICIPANT ON THE WAITING LIST. NO REFUNDS WILL BE MADE AFTER THE “NON-REFUNDABLE” DATES AS OUTLINED ABOVE.
